# SOUTH HUTCHINSON PLANNING COMMISSION Meeting Minutes

# CALL TO ORDER / ROLL CALL

The South Hutchinson Planning Commission met in regular session. The following members were present:

#### **SPECIAL PUBLIC HEARINGS**

# <u>Case No. 2025-8 – Conditional Use Permit (Evergy, Electrical Power Plant – I-3 District)</u> Motion to Open Public Hearing:

Commissioner Bryant moved, seconded by Commissioner Chastain. *Vote: 8-0. Motion Carried.* 

#### **Applicant Presentation:**

Jason, representing Evergy, presented the proposed development plan and described the layout of the facility. He emphasized that Evergy would comply with all applicable environmental regulations, including KDHE, EPA, state, and federal requirements. He noted that fire protection would be provided by on-site hydrants and suppression systems, the property would be fenced and secured, and law enforcement would be available from city or county police.

#### **Public Comment:**

Attorney Randy Rathburn spoke in opposition on behalf of the Oatney family. He stated
that the family did not believe the Planning Commission would deny Evergy's request but
wanted their concerns on record. He argued that the facility would diminish the value of
the Oatney property, which is located approximately 3,000 feet from the proposed site. He
expressed concern about constant industrial noise, potential contamination of soil and

water, and long-term impacts on the rural character of the area. He asked whether construction noise would occur 24 hours per day for multiple years.

• Response from Evergy (Jason): Jason stated that construction would be limited to 8–10 hours per day, not around-the-clock, and that noise would not exceed normal construction levels. He reaffirmed that water use and discharge would be managed under KDHE permits and oversight, and that Evergy would operate in compliance with environmental standards.

#### **Commissioner Discussion:**

- Commissioner Bryant stated that she did not believe the anticipated construction noise
  would be out of character for the area, noting that the Oatney property already contained
  aircraft, farm equipment, and nearby railroad activity, all of which generate comparable or
  greater noise. She suggested that, if necessary, additional conditions regarding construction
  noise could be considered, but she did not believe the issue warranted denial.
- Commissioner Estes asked specifically about water discharge and its regulation. Jason confirmed that Evergy would work directly with KDHE to ensure proper handling and monitoring of any discharge.
- Commissioner Cokeley commented that the facility would be required to meet the same environmental safeguards as any other industrial development in Kansas and that state and federal regulators would oversee compliance.
- Commissioner Chastain questioned Mr. Oatney regarding the proximity of his residence to the proposed facility. Mr. Oatney estimated that the new plant would be located near the middle of his property, roughly 3,000 feet away.
- Commissioner Bryant asked about fire and police protection. Jason explained that Evergy would provide on-site fire hydrants and its own fire suppression measures, while law enforcement services would continue to be provided by local agencies.
- Commissioner Duvall noted that fencing and secured access would help address security concerns, and expressed confidence that the site would be adequately protected.

# FINDINGS OF FACT Case Nos. 2025-8; 2025-9; 2025-10

For each case, the Commission made the following findings in accordance with K.S.A. 12-757 and Article 34 of the South Hutchinson Land Development Code:

- 1. **Notice:** Notice of each hearing was properly published in the official city newspaper at least 20 days in advance and mailed to property owners within 200 feet.
- 2. **Development Plan:** A development plan was submitted pursuant to Article 20.
- 3. **Review Criteria:** The Commission considered:
  - o Compatibility with surrounding zoning/land uses.
  - o Impact on public health, safety, morals, and welfare.
  - o Conformance with the City's Comprehensive Plan.
  - o Adequacy of streets, utilities, drainage, police, and fire protection.
  - o Impacts on value, use, and enjoyment of neighboring properties.
  - Compliance with requirements for parking, circulation, screening, signage, and lighting.
- 4. **Conclusion:** The Commission determined that each proposed Conditional Use Permit, as shown on the development plan and subject to conditions, met the required factors and would not adversely affect the community.

# **Conditions of Approval (All Cases):**

1. Development shall be carried out in substantial compliance with the approved development plan.

#### **RESOLUTION NO. 25-05**

A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF SOUTH HUTCHINSON, KANSAS, ADOPTING THE RECOMMENDATIONS OF THE PLANNING COMMISSION TO REZONE CERTAIN PROPERTIES FROM AGRICULTURAL (AG) AND RESIDENTIAL (R-2) DISTRICTS TO I-3 HEAVY INDUSTRIAL DISTRICT.

WHEREAS, The South Hutchinson Planning Commission held duly noticed public hearings on September 2, 2025, to consider zoning change requests for properties located along South McNew Road, Hutchinson, Kansas; and

WHEREAS, Notice of said hearings was published at least 20 days in advance in the official city newspaper and mailed to all property owners within 200 feet of the subject properties, in compliance with Article 34 of the Land Development Code and K.S.A. 12-757; and

WHEREAS, The Planning Commission, after hearing staff reports, applicant presentations, and public comment, recommended approval of the rezonings by unanimous vote of the members present; and

WHEREAS, In making its recommendation, the Planning Commission considered the factors required by Section 34-105 of the South Hutchinson Land Development Code, including consistency with the Code, neighborhood character, changed conditions, compatibility with nearby land uses, suitability of property, availability of services, amount of similarly zoned land, staff recommendations, conformance with the Comprehensive Plan, the balance of public welfare and hardship, and other relevant factors presented in the record; and

WHEREAS, The Governing Body has duly considered the Planning Commission's recommendations, the evidence presented, and the applicable factors under the Land Development Code, and finds that the rezonings are consistent with the City's Comprehensive Plan and promote the health, safety, and general welfare of the community.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SOUTH HUTCHINSON, KANSAS:

Section 1. Rezoning Approval.

The following properties are hereby rezoned to I-3 Heavy Industrial District, subject to compliance with the Land Development Code:

Parcel 1 (Public Hearing Notice #2025-5): S. McNew Road, Hutchinson, KS 67501. From Ag Agricultural District to I-3 Heavy Industrial District.

Legal: Yoder Township, S31, T23, R05W, Acres 127.5, NW/4 LESS RD & HWY R/W.

Parcel 2 (Public Hearing Notice #2025-6): 3916 S. McNew Road, Hutchinson, KS 67501. From R-2 Residential District to I-3 Heavy Industrial District.

Legal: Yoder Township, S31, T23, R05W, Acres 4.7, TR COM 30 FT W of SW COR NW ¼ N 200 FT E 1050 FT S 200 FT W 1050 FT TO POB.

Parcel 3 (Public Hearing Notice #2025-7): S. McNew Road, Hutchinson, KS 67501. From Ag Agricultural District to I-3 Heavy Industrial District.

Legal: Yoder Township, S31, T23, R05W, Acres 153.5, SW/4 EXC TR BEG SE COR SW/4 TH W 400FT TH N 400FT TH E 400FT TH S 400FT TO POB LESS RD R/W.

Section 2. Effect.

The official zoning map of the City of South Hutchinson is hereby amended to reflect these rezonings.

Section 3. Effective Date.

This Resolution shall be in full force and effect from and after its adoption by the Governing Body.

#### SOUTH HUTCHINSON CITY ATTORNEY AGREEMENT

This Agreement made and entered into this \_\_\_\_ day of October, 2025, by and between:

CITY OF SOUTH HUTCHINSON, by and through its governing body, sometimes hereinafter referred to as CITY; and

GRAFFMAN & SMITH, LLC, by Cody R. Smith, sometimes hereinafter referred to as ATTORNEY;

#### WITNESSETH:

WHEREAS, CITY is desirous of retaining ATTORNEY as its City Attorney to represent the City of South Hutchinson; and

WHEREAS, ATTORNEY is desirous of serving as City Attorney for the City of South Hutchinson, Kansas.

NOW THEREFORE, for and in consideration of the premises and mutual covenants herein contained, the parties hereto do hereby agree as follows:

- 1. CITY hereby retains ATTORNEY as its City Attorney to provide legal representation for the City of South Hutchinson, as hereinafter described. ATTORNEY agrees to provide professional legal services to CITY. CITY agrees to pay ATTORNEY the sum of One Hundred Sixty Dollars (\$160) per hour. Such hourly rate shall include the following routine legal services, to-wit:
  - a. Attendance at regularly scheduled City meetings;
  - b. Legal advice to the City Administrator, department heads, and City staff, including any communication and research incident thereto regarding City-related matters;
  - c. Legal advice and research to the Mayor and City Council Members regarding Cityrelated matters:
  - d. Research and drafting of any City ordinances in the normal course of business;
  - e. Legal advice to any and all law enforcement officials pertaining to City criminal and traffic cases;
  - f. Prosecution of City criminal and traffic cases in the Municipal Court of the City of South Hutchinson, Kansas, which court is presently held two (2) times per month; and
  - g. Attendance at periodic special meetings requiring ATTORNEY's presence.
- 2. ATTORNEY shall control the conduct and means of performing the work required under this contract and shall perform all services required under this contract in a manner consistent with professional standards. ATTORNEY may maintain other legal employment separate from this contract but shall devote the time and skills necessary to provide

effective and competent representation to CITY.

- 3. ATTORNEY shall bear the cost and expense of maintaining its license to practice law.
- 4. ATTORNEY shall bear the cost and expense of maintaining Professional Liability insurance coverage.
- 5. ATTORNEY is authorized to hire outside legal counsel to perform work for CITY without the need to have such work approved by resolution provided that: (i) the total amount for each matter does not exceed \$5,000; and (ii) the legal services are billed showing the date services were rendered, describing the services and providing the time expended on each date. A copy of the bills shall be included with ATTORNEY's monthly invoices for City Attorney expense reimbursement. In the event that ATTORNEY determines that additional work of legal counsel is necessary for a particular matter that would exceed the \$5,000 limit, then ATTORNEY shall obtain authority by written resolution of the City Council for those additional services.
- 6. Both parties acknowledge that due to the nature of the City Attorney's role, it is not possible for the City Attorney to represent or provide legal advice to individual citizens, groups, or other entities regarding City-related matters.
- 7. In addition to the routine services provided by ATTORNEY on behalf of CITY, other legal representation may be provided if mutually agreed to by the parties, but such representation will be billed for and paid by CITY in addition to the fee above described. Such legal services will be billed monthly at the hourly rate of Two Hundred Twenty-Five Dollars (\$225) per hour, plus expenses, and shall include the following:
  - a. Any civil litigation in which the City of South Hutchinson is involved either as a plaintiff or defendant.
  - b. Appeals from any municipal court cases to the District Court of Reno County, Kansas, or to the Court of Appeals of the State of Kansas, or the Supreme Court of the State of Kansas.
  - c. Any other matters discussed on a case-to-case basis and agreed to by CITY and ATTORNEY.
- 8. ATTORNEY shall submit to CITY an invoice for its fees and expenses on at least a monthly basis, not to exceed two invoices per month. CITY shall pay ATTORNEY's fees and expenses within thirty (30) days of receiving an invoice.

- 9. This Agreement shall automatically renew each year unless either Party provides to the other by November 30th of each year written notice of its desire not to automatically renew the Agreement. Either party may terminate and cancel this Agreement upon giving ninety (90) days of notice to the other party. The ninety (90) days of notice shall commence to run, for a termination by CITY, as of the end of the month when the notice is delivered. ATTORNEY shall be entitled to receive compensation through and including the last day of the termination period.
- 10. The parties acknowledge that appropriation for payments hereunder is a governmental function that the CITY cannot contractually commit itself in advance to perform, and this Agreement does not constitute such a commitment. However, the CITY reasonably believes that monies in sufficient amounts to make payments in the Agreement can and will lawfully be appropriated and made available to permit CITY's continued receipt of ATTORNEY's services. The CITY will use funds appropriated for this Agreement for no other purpose other than to pay the ATTORNEY hereunder. The CITY is obligated only to pay such payments under this Agreement as may lawfully be made from funds budgeted and appropriated for that purpose during the CITY's current budget year. Should the CITY fail to budget, appropriate, or otherwise make available fund to pay amounts owing on this Agreement, then this Agreement shall be deemed terminated no later than at the end of the current year. The CITY agrees to deliver notice to ATTORNEY of such termination at least 90 days prior to the end of the calendar year, but failure to give such notice shall not extend the term beyond the current year.
- 11. CITY shall defend, hold harmless and indemnify ATTORNEY in the event the ATTORNEY is made, or is threatened to be made, a party to any proceeding by reason of his status as City Attorney, or by reason of any alleged act or omission which occurred while he was acting as the City Attorney, including but not limited to any alleged claim, fine, penalty, demand, or other legal, equitable, or statutory action, whether groundless or otherwise, which arises out of the apparent scope of his work or his authority as City Attorney. This provision shall survive the termination of this agreement.
- 12. This Agreement shall not be deemed to create the relationship of employer-employee between CITY and ATTORNEY, and no rights or privileges of an employee of the City shall inure to ATTORNEY.
- 13. This Agreement shall be binding upon the parties hereto, their respective heirs, devisees, legatees, executors, administrators, personal representatives and assigns.
